Compliance notice

How to pay contributions to EISS Super

If you are a registered EISS Super employer (that is, you already pay contributions to EISS Super on behalf of other members), you can simply continue using your current payment method for contributions.

If you are not a registered EISS Super employer, you can register to make payments at eisuper.com.au/employerregistration. Registration takes a couple of minutes. Once you have registered you get instructions about how to pay employees' super using EmployerAccess.¹

You can also submit contributions to EISS Super using an alternative service that meets the Government's minimum data standards as legislated in the Stronger Super reforms.
